

Jill Just Wants 2 Help In Memory of Jillian Aggie Siegel

In 2008, at the age of 20, Jillian Aggie Siegel was diagnosed with acute myeloid leukemia (AML). Acute myeloid leukemia (AML) is cancer that starts inside bone marrow, the soft tissue inside bones that helps form blood cells. The cancer grows from cells that would normally turn into white blood cells. Acute means it develops quickly.

Hours, weeks, and months were spent watching her go through treatments, hoping, that at some point, she would be able to go through a bone marrow transplant in order to be given a second chance at life. The agony of the search for the perfect match, as well as the treatments in order to get the patients body ready for the transplant, is an agonizing process. Though Jill's resolve was tested, she never lost her direction for even a moment. Unfortunately, she lost her battle.

It is in her memory that her parents, Phil and Nancy Siegel, realized the urgency for patients desperate for transplants and the need for available financial resources to answer the many needs facing both patient and families.

The Siegel family has recently formed an alliance with Hospital of the University of Pennsylvania (HUP). JJW2H will provide a permanent fund to help support families requiring financial assistance with adolescent children, teens and young adults in their twenties battling leukemia/ myeloma. Eventually, with the generous support of people like you, JJW2H hopes to establish "Jill's House", a supportive housing facility, in close proximity to HUP, for patients undergoing treatment and their families.
